### Lieutenant

The Chesterfield Police Department is currently accepting applications for Police Lieutenant. Salary up to \$93,496 (2025) depending on experience.

The Chesterfield Police Department is located at 490 Route 63 in Chesterfield NH, right next door to the Chesterfield Fire Department and the Chesterfield School. We serve approximately 3,600 residents across 47 square miles. Members of the Chesterfield Police Department are committed to being capable, caring, and professional, working for the benefit of all citizens within our community.

**GENERAL STATEMENT OF DUTIES:** The Lieutenant is the second in command of the Chesterfield Police Department and reports directly to the Chief of Police.

**DISTINGUISHING FEATURES OF THE LIEUTENANT:** The Lieutenant, under the direction of the Chief of Police, oversees the operation of the Chesterfield Police by assisting in planning, directing, managing, controlling, and coordinating the activities of the department to promote and ensure that Chesterfield residents are provided the highest level of police service.

#### **Job Summary:**

The Lieutenant performs responsible administrative and technical supervisory work in directing the operation of the police department. In the absence of the Chief, the Lieutenant, as second in the chain of command, assumes the powers, duties, and responsibilities of the Chief. The Lieutenant shall perform all patrol and investigative procedures performed by police officers. The Lieutenant promotes an ongoing attitude of dedication to excellent public service and ensures that residents and non-residents are provided with the highest quality of service.

#### **Supervision Exercised:**

The Lieutenant exercises general supervision over all patrol officers and civilian employees. Provides training, instruction and guidance to all patrol personnel and reviews and evaluates their work performance. Evaluates, and recommends selection, performance and discipline of patrol personnel. Receives and investigates complaints against all Department personnel apart from the Chief and provides recommendations for disciplinary action if warranted, to the Chief.

#### **Minimum Qualifications Required:**

Minimum of four years of experience in law enforcement. Supervisory experience is preferred. Experience in patrol with emphasis on investigations and court prosecutions. Possession of a valid motor vehicle operator's license. Possession of valid N.H. Full Time Police Officer certification is preferred.

## TRANSFER STATION NEWS

The following is the information sent by the State of New Hampshire DES.

Starting July 1, 2025, rechargeable **lithium-ion batteries will be prohibited from disposal** in New Hampshire's landfills and incinerators. Lithium-ion batteries are used in a wide variety of consumer products, including:

- Automotive vehicles.
- Electric bikes and scooters.
- Lawn care equipment.
- Portable electronics such as cell phones, laptops, tablets, cameras, wireless headphones, speakers, toothbrushes and other rechargeable electronic devices.
- Cordless power tools.
- Toys.

### **Why is there a disposal ban?**

Lithium-ion batteries contain hazardous metals and can pose safety hazards when improperly managed. When crushed or damaged in any way, they can ignite – causing intense fires. For these reasons, **lithium-ion batteries should never be put in the trash or curbside recycling bin!** Lithium-ion batteries have become a leading cause of fires for trash haulers and waste management facilities. A recent [report by the National Waste and Recycling Association](#) estimates that each year more than 5,000 fires occur at waste management facilities nationwide, many likely caused by lithium-ion batteries. Fires are not only a safety hazard to waste staff and the public; they also can result in hundreds of thousands of dollars in damages to expensive equipment and buildings.

In an effort to reduce the safety risks associated with improper disposal of lithium-ion batteries, New Hampshire State Rep. Karen Ebel introduced [HB 1386](#), which proposed to add such batteries to [the list of wastes already banned from disposal](#). The bill gained the support of the [New Hampshire Solid Waste Working Group](#), industry experts, waste haulers and municipalities, and was signed into law by Governor Sununu.

### **Who does the ban apply to?**

Starting July 2025, **households and businesses must recycle their lithium-ion batteries**. Lithium-ion batteries must be recycled through special battery collection programs – never mixed with regular recyclables.

### **Where can I recycle my lithium-ion batteries?**

Many New Hampshire municipalities and businesses, like [Staples](#), [Best Buy](#) or [BatteriesPlus](#) offer collection boxes for recycling rechargeable batteries. To find a drop-off site nearest to you, contact your local transfer station, check [Call2Recycle.org](#), or visit one of the retail locations mentioned above. **Remember – if it's rechargeable, it's recyclable!**

## CHESTERFIELD CONSERVATION COMMISSION

The blasts of yellow and splashes of green have indicated that the warmer seasons are upon us. We can still find ourselves with those up and down temperatures but we are gradually leaving the chilly days behind. And with this shift our outdoor tasks start piling up. Being one who lets my plants provide food and shelter over the colder months, I have plenty to keep me busy.

I am a lover of grasses so one of the first things is cutting them back to about six inches, making sure I don't wait too long to avoid cutting the new growth. Trimming and clearing away hosta and fern remnants is yet another task. And of course, taking advantage of any of the stealthy invasive plants trying to set up shop on the property.

The Spring and Fall, as I've mentioned before, are a great time to slowly move around your yard, looking for the aggressive invasive plants as they are much easier to see and easier to remove. The other issue to give thought to is how dry it has been. Through the simple act of observing over time, it was appearing to me that, in addition to less rain, evaporation was happening more quickly. When I did some research, that is indeed the case. So with that in mind, think mulch and how long to let your grass grow before cutting and the height you cut it at. This will help protect the roots of the grass. Just as we care for the plants in our gardens, so to the grass.

The other thing to give thought to is how much and what kind of planting we want to do with the potential of an extended dry season. Both the energy and effort of watering everything needs to be considered and of course, your well. When we bought our house over 30 years ago the owners shared a saying with us, one I've not forgotten, "Showers or Flowers". You can have both. Doing some research, asking questions of knowledgeable folks can help you make good choices for you and your property. And a reminder, you can find some helpful links at the CCC website such as the Native Plant Trust, Invasive Plants as well as UNH Extension, which has a wide variety of topics you might find interesting and helpful.

## Chesterfield Cemetery Commission

Chesterfield Cemetery gates open May 1st through September 30th, from 9 A.M. until 7 P.M., and October 1st through November 1st, from 9 A.M. to 6 P.M. Thank you to our three gatekeepers for tending the gates!

The crew has been working the last month to prepare the cemeteries for the upcoming season. We kindly ask that you do your part by removing your winter decorations by May 15th.

For the summer months we recommended temporary in-ground plantings that are hardy and drought resistant. NO permanent plantings are allowed, this includes rosebushes, hydrangea, lilac and evergreen bushes. Oversized existing plantings will be removed as they interfere with the care of the gravesite.

Extraordinary displays that interfere with the care of the gravesite are also discouraged.

If you have any questions, feel free to reach out to a Cemetery Commissioner or attend one of our meetings. Meetings are held at the Historical Society building on the 2nd Wednesday of the month at 6:30 P.M.

## Office of Emergency Management (OEM) – May Monthly Report

OEM is a complementary organization to the Chesterfield Police, Fire and other resources and are available to assist in any emergency. A major focus of our OEM team is to prepare for the eventuality of any disaster event – fire, floods, power outages, etc. – and plan to host facilities at the Town Hall to provide power, snacks, shelter, etc.

### Spring 2025 Activities

1. CPR, AED and Safety Training will be starting soon. Please look ON Social Media and notices from the town, library and school in May for the dates and times. We will be contracting with a local Keene firm where some of us took the course and they were EXCELLENT. The fees will be \$10 for CPR/AED (1-2 hours) and \$55 for CPR/AED/Safety Training – certification which is included in the Safety Training (4-5 hours). 2. Education – Helping residents learn how to identify and respond to disaster events. With many incidents occurring in communities like ours, our OEM team is committed to stepping up our community training activities. This is our NUMBER ONE objective for 2025. 3. Collaboration – Our OEM team has begun collaborating with School and Library officials on awareness programs that can be as simple as “change your smoke alarm batteries” or “take CPR training.” We appreciate the support of these valued partners and our OEM volunteers.

4. Partnering – Through outreach to state agencies and neighboring towns, our OEM team has assured continued commitment to assist in our efforts.
