Board of Selectmen Notes

August 2024



Spofford Lake's chief advocate and steward, Bayard Tracy was honored by NHLAKES with the John F. Morten Award for Exemplary Lake Stewardship on July 27. NHL's Chairman and President, Bruce Freeman and Andre LaMoreaux, respectively, presented the award saying that Bayard's nomination received more than 30 letters of support, perhaps the largest number of such in the 20-year history of the award. Beyond all his accomplishments, equally noteworthy was the wide range of letters of support including the Chesterfield Conservation Commission, Town Select Board members, FB Environmental, reps from the State, the SLA Board, and friends and residents of Chesterfield.

Chesterfield Select Board member Gary Winn reflected on working with Bayard some 15 years ago on the Budget Committee. It was shortly after this that Bayard first introduced and town voters endorsed the "Invasive Species Expendable Trust Fund." 2024 was the fifth year to earn voter support. Winn also mentioned Bayard's participation on the Town's Watershed Committee and his recent work to refurbish the Lake's boat ramp.

Tracy said, he was "truly honored to receive the Morten Award and to be among the leaders in the State looking out for their "home" lakes and the well being of all waterbodies. He all-too-modestly noted that he was merely the leader of a team of a dedicated group of folks committed to assuring the long healthy life of Spofford Lake,

NHLAKES established the Morten Award in 2002 to honor of the late John F. Morten as a tribute to his vision, dedication, and commitment to help protect NH's lakes and ponds.

As one SLA member said "...this award is well-deserved...we have witnessed and experienced first-hand Bayard's impact on the direction of the Spofford Lake Association. It has evolved from a social group to a formidable steward of our lake."

COMMUNITY POWER NEWS

2024 Community Power Coalition Announces New Rates
CPCNH continues to deliver competitive rates to member communities

CONCORD –The Community Power Coalition of New Hampshire (CPCNH) Board of Directors has announced a base electric rate for residential and small commercial customers that is expected to save \$11 million over this next six-month rate period. These savings will add to the more than \$14 million of community savings since CPCNH launched in April of 2023. The 8.6¢ per kilowatt-hour (kWh) rate will begin on August 1, 2024. The Coalition will again offer their customers additional energy choice options with 50% and 33% clean power plans at a lower rate than power from Eversource, Utili and Liberty in addition to a 100% clean energy option.

The Coalition is now providing default energy service to more than 130,000 customers in 43 communities statewide with several dozen additional cities and towns in the process of launching programs soon. The Coalition continues to offer among the state's most competitive energy rates saving residential and small commercial customers 22% relative to Liberty Utilities' supply rates and 18% relative to Utili and Eversource supply rates. Eversource mid-sized

commercial customers will pay on average 49% less for energy supply through Community Power than they would have with Eversource. "CPCNH empowers communities to better control their energy future with enhanced local control, greater customer choice, and low competitive rates," said Brian Callinan, CEO of CPCNH. "We are excited to continue to deliver on these goals and create significant cost savings for our communities, including for those customers looking for more renewable energy," continued Callinan.

Community Power, authorized under NH RSA 53-E, empowers towns, cities, and counties to choose where their electricity comes from. Community Power enables municipalities and counties to become the default electricity provider for their communities. Under Community Power, electric distribution utilities continue to own, operate and maintain the power lines and infrastructure while local communities gain control over the cost of their energy and where it is sourced from. Many more New Hampshire towns and cities have begun the process to launch their own programs in the coming months and years. More than 50 communities have already joined the Community Power Coalition and are currently in the process of launching their own Community Power programs. CPCNH electricity rates are among the most competitive in New Hampshire. Please refer to communitypowernh.gov for rate comparison tables.

As always, our thanks to our Selectmen, Town Admin & volunteer members of the OEM team for their support. Here is a sampling of OEM activities underway in Chesterfield:

1. Route 9 Accidents – Please make sure you drive safely on Rt. 9 and other roads in our community. We had several accidents and the police are to be thanked for their efforts. Please tell your out-of-town visitors of the need to do so. Thanks!

2. Grants - We are assessing whether our OEM priorities might be eligible. We may to hear about available Grants from other communities – soon to be underway.

3. Animal care – Cheryl, Karen, John and Ralph are looking into a way that we can stock animal provisions (food, bowls, cages) to be acquired by Labor Day.

4. Old Town Hall – OEM's generator kept at Road Agent/move over when needed.

5. Local businesses – MOUs mtgs for partnering w/ OEM for transportation, etc.

6. WebEOC training – available for interested personnel for communications.

7. Collaboration w/local communities – HSEM event held in Peterborough on 5/29.

8. Emergency Supplies – to be added to our 500 MREs, cots, blankets, water, PPE.

9. Mailing lists – Fran will assist with Opt-In mailings requests from other sources.

10. Special assistance – analyzing needs for residents to relocate during disasters.

11. Mutual Aid - Check in w/Spofford and West Chesterfield Firehouses for support.

12. Training – Ralph and John are registered for ICS 300 training we had the ICS 100/200 levels. Training will be by the Massachusetts Emergency Mgmt Agency.

13. Maine partnering – Ralph met with the Maine Emergency Mgmt Agency for new ideas. We also received names of their key contacts in NH for our information.
