Land Development – Lynne is preparing a presentation regarding land for donation for the Selectmen. The Summers property transferred to the Monadnock Conservancy on May 10<sup>th</sup> for \$50,000.

Spofford Lake Report –

A). Pam reported that the Current Lake Level is 11.25 inches; 2 inches higher than normal summer level.

B). Lynne stated that she & Bob had become members of the B&K Beach Club for the purpose of becoming SLA representatives.

Grants & Events –

A). Lynne stated that she had found projects for the VT Youth Conservation Commission with other organizations. The Commission does not have week long projects at this time.

B). Lynne stated that Bear Mountain Trail needed more Blue Diamond Signs. Jeff moved to purchase 100 from the Budget. The Motion was seconded by Pam and passed unanimously.

Other -

A). Pam asked about the Highway Department Workers trained to spray herbicides for invasives. She had recently learned that the 25 feet for wetlands does not apply to licensed applicators, so are there 2 members of the department that have completed training? The Japanese Barbary has taken off in Friedsam.

B). Pam asked about notifying renters about the Fireworks ordinance. Jeanny was going to see if a mailer could be sent out and a banner hung out at the boat ramp.
